- Tech host transcription duties There was an incident of the meeting being transcribed and then the function was turned off and no one has seen it since. Person who it happened to believes it was an accidental one time incident. Gordy received notification.
  - -May be worth adding a step to Tech Host.
  - -Zoom admin can disable it for all meetings. Can we decide that here or in future GC?

#### 5. OLD Business:

- Six month term limits
  - -Originally difficult to fill positions. Conventional terms are 6 months.
  - -October notes show it was voted on and did not pass
  - -Topic withdrawn
- Use of music at end of meeting
  - No longer playing
  - -Wonders if it needed to be regulated if people enjoyed since it was post 8:45
  - -Love music but feels inappropriate for AlAnon because outside subject -Was in discussion in October but then glossed over without follow up.

Concerned about loss of follow up. Personally enjoyed it. Wonders if it could be a breakout room for those who enjoyed it.

- -Anyone has the ability to play music if they wish, maybe host/co-host can use discretion to stay over for fellowship.
  - -If parking lot is for newcomers, music does not help with that.
- -Thinking of literal parking lot helps to keep it separate from the meeting. Adds that feels distracted by people doing other things during actual meeting. -Found music jarring, distracting, non al-anon.
  - -Music is out of my control. Take what you like and leave the rest
- -Gentle announcement that we will play music and if you do not want to hear you can exit.
- -Discussed at length in November. Wouldn't be an issue if people were hanging out but it became issue of dominance because host was being asked to grant co-host to play and was single person out of 300 choosing music.
- -Discussion is different from original item on agenda "use of music for timing" -Follow KBM, but don't see much unanimity in discussion so no motion to take a vote on.
- -Issue was originally raised because of complaints about the request/pressure to be made co-host
- -Differences of personalities, so meeting vs fellowship. Question is whether there is an after space which we don't regulate
- -Music is too personal and not elective because everyone hears it so if you don't like it you are forced to leave
- -As a fellowship we paid for zoom for meeting so should go somewhere else for fellowship
- -Grateful to watch people reason it out. Newcomer safety as primary boundary. Host role is to maintain safety.
  - -Always asked host if they minded if we play a tune.
- -Music was played in good will and it felt like exit music but important to be safe and inclusive. But outside of zoom music was only used with careful advanced discussion.
  - -GC CHAIR tables discussion to return to unfinished New Items.
  - -Is there CAL approved music
  - -Grateful I can use this as place to speak up and defend myself
  - -Keep an open mind and open heart
  - -Clearly no unanimity and it is an outside issue.

CONCLUSION: Needs formal motion, focused on how to end the meeting.
